



ALIGN is a three year project which aims to contribute to the enhancement of the intelligibility, consistency and transferability of qualifications through establishment of mechanisms for HEIs to achieve alignment of academic programmes with NQFs and for QA agencies to check such alignment.



Specific objectives of the project are:

- To promote a better understanding of HEIs and EQA agencies of the role of QFs, their structure, as well as the differences between the different kinds and levels of student achievement
- To build on the capacity of HEIs to write and access learning outcomes that define the various types of student achievement
- To build on the capacity of the HEIs to use the QF alignment to facilitate student transfer, joint qualifications and benchmarking
- To enable the EQA agencies to check whether proposed learning outcomes and their assessment mechanisms match of QF descriptors at each level by establishing mechanisms for ensuring consistency of

- Adoption of the alignment tools at HEIs, QAA agency and governmental levels.




